West Central Wardens and Superintendents Association Annual Business Meeting September 12, 2007

The business meeting of the West Central Wardens and Superintendents Association was held on September 12, 2007 at the Inn on the Park in Madison, Wisconsin. Board members present were:

President Jodine Deppisch presided over the business meeting which began at 10:20 a.m. beginning with introductions of the board members and the administrative assistant, John Thalacker to the membership.

Treasurer's Report – Terry Carlson

- Bank balance at the 2006 WCWSA conference was reported at \$19,537.44. At last years conference it was noted that there were several outstanding membership and conference registration fees to process and a number of conference expenses to be paid. The bank balance in mid-October, after all conference income and expenses were recorded, was \$14,296.52.
- In December 2006 all funds were transferred from the First State Bank in Bayport, Minnesota to the First Federal Savings Bank in Fort Dodge, Iowa.
- As of August 31, 2007 the bank balance was \$14,320.38. Estimated revenues for 2007 conference are approximately \$10,402.50 and estimated expenses are approximately \$11,129.00. The estimated balance at the conclusion of the 2007 conference is approximately \$13,594.00
- On September 10, 2007 the board of directors approved refunding conference registration fees minus annual membership fees to two members who recently cancelled their attendance in the 2007 conference.

Old Business:

- Review of 2006 annual business meeting minutes
 - o Motion by David Crist, s/ by Dan Buchler to approve the meeting minutes as written. Carried unanimously

New Business:

- Administrative Assistant: By-laws state that the president may appoint an administrative assistant for a one year period and that each year at the annual business meeting a decision will be made as to continuation of the position.
 - o Motion by Terry Mapes, s/ by Tim Schuetzle to have John Thalacker continue in the position of Administrative Assistant for the upcoming year. Carried unanimously.
- Nominating Committee: Don Redmann, chair and past presidents compose the nominating committee. The committee recommends the following members for officer positions:
 - o President Terry Mapes
 - o Vice President Mike Murphy
 - o Secretary/Treasurer Jessica Symmes

- o Motion by Judy Smith, s/ David Crist to accept nominating committee recommendations. Carried unanimously.
- Recognition of new members and past presidents:
 - President Deppisch recognized and welcomed new members. From Wisconsin Suzanne Schmitt, Ana Boatwright, Floyd Mitchell, Diedra Morgan, Greg Grams, Cathy Jess, Mike Thurmer; from Oklahoma Haskell Higgins; from Iowa James Carter,
 - Administrative Assistant John Thalacker summarized the history of the states represented by the WCWSA presidents since the inception of the organization in 1949. Of the previous presidents 6 have been from Minnesota, 5 from Missouri, 5 from Colorado, 4 from Iowa, 3 from North Dakota, 3 from British Columbia, and a number of other states have had one or two representatives who have served in the president's position. John Thalacker mentioned that he will be working to encourage other states to participate and host a conference in upcoming years.
 - o Administrative Assistant John Thalacker recognized the past presidents who are in attendance at this conference David Crist, Judy Smith and Don Redmann.
 - O David Crist recognized Past President Mike Kemna from Missouri who has been a long standing supporter of the WCWSA and has recently been promoted within the Missouri Department of Corrections. Administrative Assistant John Thalacker requested the Secretary/Treasurer to send a note of congratulations from the organization to Past President Kemna.
- Resolutions: The resolution committee consisting of Terry Carlson, chair and John Thalacker presented the resolutions which were read by Jodine Deppisch recognizing those who were associated with organizing, presenting and making the conference a success. The resolutions were approved with the following additions:
 - o Recognition and thanks to First Lady Jessica Doyle who greeted us during our tour of the Governor's mansion.
 - o Recognition and thanks to the people listed in the conference brochure for the work they did to make this conference a success.

 - Other names given to Terry Mapes as possible presenters included Gary Moore, Ohio and Robert Hare.
- Recognition of Board Members: Jodine Deppisch presented plaques to Vice President Terry Mapes, Secretary/Treasurer Terry Carlson. Terry Mapes presented a plaque to President Jodine Deppisch.
- Membership: President Deppisch thanked all members for their participation in this conference.

- Newsletter/Information Dissemination: Past President Don Redman notified the group that he will send out a group email to the membership with emerging trends, current issues, etc.
- Recognition of program or person: Past President Don Redmann asked the board and the membership to think about whether WCWSA should develop a process of nomination, selection and recognition of a program or individual.
